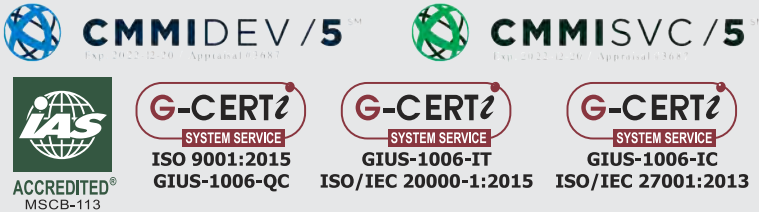
CORPORATE OVERVIEW
