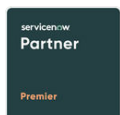

Prime Past Performance Examples

Website Development, O&M, and Testing Services

Challenge: Improve Medicaid.gov and InsureKidsNow.gov websites to help Center for Medicaid and CHIP Services (CMCS) ensure smooth operations and to bring innovation and efficiency to its processes to provide services to over 93 million enrollees.

Solution: Sky is helping CMCS institute a SAFe, DevSecOps culture and piloting innovations such as intelligent automation to streamline processes for publishing content and improve navigation.

USCDI+ Data Set Development

Challenge: The current ONC submission system faces issues related to inflexibility in managing complex relationships between classes, elements, and use cases, resulting in efficiency problems in collaboration and approval processes.

Solution: Develop, deploy, and provide site maintenance for a new platform in support of United States Core Data for Interoperability Plus (USCDI+) data set development and feedback collection.

Benefit: Our solution streamlines and automates ONC's USCDI+ submission processes, reducing manual work, minimizing errors, and improving efficiency.

DoD Defense Media Activity (DMA) Web NextGen Pilot

Challenge: DMA requires a best-in-class, secure, and user-friendly technology infrastructure for the Web Enterprise Business (DMA-Web.mil) public web, content management system, and integrated services for over 1000 public-facing websites across DoD components.

Solution: Sky is modernizing DMA technology infrastructure and DMA-Web.mil platform which will address the future needs of DMA and DoD stakeholders.

Benefit: Sky is enabling a DMA-Web.mil future architecture that is widely interoperable and allows seamless moving of content within and between websites as well as to social media, mobile apps, automated emails, and other distribution/notification mechanisms.

IRS Safeguards IT Services

Challenge: The IRS Safeguards need to increase the security of Federal Tax Information (FTI) and ensure consistent application of information security standards across all partner agency information systems.
