#### Strategy, Policy, Performance Management, Stakeholder Engagement

We support implementation of National Security Memorandum (NSM)-22, manage Federal Senior Leadership Council working group initiatives and lead a redesign of the Sector Risk Management Agency (SRMA) Sector Liaison Program, consistent with CISA's Fiscal Year 2021 National Defense Authorization Act (FY21 NDAA) Section 9002(b) Recommendations Report. We also support the development of a sector management performance measurements framework, including a maturity model to establish a baseline assessment of each SRMA's ability to perform the six required functions articulated in the FY21 NDAA.

### Strategy, Policy

We formulate infrasturcture security policy and governance frameworks that integrate strategic priorities with resources to optimize program operations. Our team leads initiatives such as the Infrastructure Security Performance Goals Pilot, enterprise-wide risk assessment standardization, and implementation of Executive Orders on BioEconomy and Undersea Cable security. Additionally, we spearhead international collaboration efforts through C5 and USMCA.

# Strategy, Stakeholder Engagement, Technical Assistance

We develop multi-year strategies to strengthen community resilience against targeted violence. We conduct nationwide roundtable discussions and listening sessions with largely underrepresented communities and non-governmental stakeholders to build coalitions between government agencies and community-based organizations. Our team also spearheads access to government resources through technical assistance programs, offering support in cyber hygiene, doxing protection, bombing prevention, active shooter training, and others.

### Risk Analysis, Program Management, Strategic Communications

We implement interagency risk management strategies and program plans to address emerging threat vectors, such as Position, Navigation and Timing resilience, Supply Chain Risk Management, Systemically Important Entities, National Critical Functions and sector risk assessments. We analyze risks to critical infrastructure assets and systemic functions, including risks associated with artificial intelligence and quantum computing, among others.
