Acquisition official completes intent to award direct award Offer Letter with description of project and identified 8(a) company to SBA Representative (in accordance with 13 CFR 124.502c)

Step 1: SBA Offer Letter



SBA reviews Offer Letter, verifies 8(a) eligibility for company identified and sends letter of acceptance to acquisition official

Step 2: SBA Review & Acceptance



Acquisition official informs 8(a) that they may enter into project scope planning and negotiations on joint development of project plan (13 CFR 124.503)

Step 3: Negotiations & Project Scope Planning



Once mutually acceptable terms are negotiated, a direct award contract is awarded

Step 4: Contract Award
