A Record of Success with the Treasury & IRS

TREASURY/OFAC

- Since 2009 TG Federal has supported modernization efforts at the Office of Foreign Assets Control (OFAC). TG currently has 8 cleared (Secret and TS.SCI) consultants supporting the development, integration, and migration of ongoing AWS cloud initiatives.

IRS – Applications Development (WebApps)

- TG Federal plays an integral role in the IRS's mission to develop and enhance Online Account Access for Taxpayers and Tax Professionals. Working across multiple service channels; Individual Online Accounts (IOLAs), Business Tax Accounts (BTAs), and Tax Pro Accounts (Tax Pro); our team (38) of developers, testers, architects, and systems engineers are dedicated to IRS's mission to improve customer service for all taxpayers.

Dept. of Treasury – Bureau of Engraving and Printing (BEP)

- Since 2010 TG Federal has supported Treasury's Bureau of Engraving and Printing (BEP)'s Manufacturing Execution System (MES) without a single gap in support. BEP serves as the Federal Reserve's currency producer and develops anti-counterfeiting technology for use in government security documents. TG Federal's service offering includes process tracking, quality management and data collection, and Oracle reporting features.

IRS - Enterprise Development, Operations Services (EDOS)

- TG Federal's commitment to pre-award efforts including incumbent capture, past performance documentation, competitive pricing, and strategy exercises resulted in being named as subcontractor (for 2 primes) on Internal Revenue Service (IRS) Enterprise Development, Operations Services (EDOS) contract, a Blanket Purchase Agreement (BPA) with a ceiling value of \$2.6 billion. The multiple-award BPA has a seven-year period of performance.

Customer Account Data Engine (IRS)

- TG Federal has provided 60+ consultants over the past 9 years in support of CADE2. Support services include Solution Architecture, PMO Support, Business Analysis, Agile Transformation, IT Modernization, and Mainframe Logic Harvesting. Implementing the Service's modernization strategy to transform individual taxpayer account processing. Our team is tackling complex system integration challenges across a large multi-year program and delivering benefits to Taxpayers including: faster refunds and improved access to account information, more timely issue resolution, and enabled web and mobile capabilities.

Return Review Program (IRS)

- Supported the Return Review Program (RRP) in fostering a collaborative relationship between Business and IT, successfully cemented RRP as the system of record for individual taxpayer fraud and anomaly detection at the IRS. Leveraged Results Management Office (RMO) thought leadership to define the Future State, the Program is now well-positioned to continue to address the tax gap.

Applications Development Vision & Strategy (IRS)

- Provided strategy and visioning support to the AD executive leadership team in defining and delivering the AD Vision future state. As a subcontractor, TG Federal drove agile program management practices to implement initiatives and transform the AD organization and culture, including transforming AD from a culture of "me" to "we" through leadership sessions and executive coaching. As a result, AD saw an increased alignment with the future state vision across the organization and a new coalition of leaders to help drive the success of the organization's strategy.

Organizational Readiness (IRS)
